As promised, I will provide you with any information gleaned during the Washington Conference in March 2025.

**The Foreign Medical Program (FMP):** We were advised the original time frame of 1st quarter 2025 for having direct deposit for reimbursement has slipped until June 2025.

We discussed what we see as a benefit for moving the Veterans Benefits Administration (VBA) Regional Office (RO) or VARO in Pittsburgh which supports 17 of our posts in DPA, to VARO Manila. Our National Veterans Service (NVS) team in our DC office continues to work this with the VA and is waiting for a new Undersecretary for Benefits to be appointed so that can bring this issue directly to him. We will continue to work on this issue.

As always we reminded VFW senior leaders and staff in both our KC & DC offices of the unique nature of our operation out here in the Pacific. Specifically we reminded all they need to ensure the DPA always receives the same opportunities as other departments JVCIC Tim Peters, Assistant Adjutant General Brian Walker, and Director of Public Affairs Rob Couture were in Bangkok visiting with the Defense POW/MIA Accounting Agency (DPAA) where they received a briefing as well as visited a site in Northern Thailand where remains are being recovered. They also visited Korea, the Philippines, and Vietnam.


We will continue to engage with fellow National Council Members as well as National Leadership in order to ensure we are recognized for our Department's many contributions to our great Organization.

## MEDAL OF HONOR RECIPIENTS

Willibald Charles Bianchi was born on March 12, 1915, in New Ulm, Minnesota. The only boy among four siblings, he grew up on a poultry farm. After his father's tragic death in a farming accident, Bianchi left high school to take over the farm and support his family. Later, he completed his education at the University of Minnesota Farm School and enrolled at South Dakota State University, majoring in animal science while participating in ROTC and playing football.

Upon graduating in June 1940, Bianchi was commissioned as an Army second lieutenant. Eager to see action, he was deployed to the Philippines in April 1941, joining the 45th Infantry and the Philippine Scouts. His unit was among the first to engage in World War II's Pacific battles after Japan bombed Pearl Harbor and invaded the Philippines. Allied forces withdrew to Bataan Peninsula to hold off the enemy.

On February 3, 1942, Bianchi led troops to eliminate two Japanese machine gun nests. Despite being shot twice in the left hand, he switched to his pistol and took out the first nest with grenades. He was shot twice more in the chest but continued fighting from atop a U.S. tank before being critically wounded. After a month of recovery, he returned to duty and was promoted to captain.

On April 9, 1942, Bianchi was captured following the fall of the Philippines, enduring the brutal Bataan Death March. He became a pillar of support for fellow prisoners, helping to lift their spirits and barter for food. Many credited him with saving their lives.

By December 1944, as Allied forces reclaimed the Philippines, Bianchi was transferred to Japan on overcrowded "hell ships." He survived the bombing of one ship, the Oryoku Maru, but was later placed on another, possibly the Enoura Maru, anchored off Taiwan. Tragically, on January 9, 1945, an unmarked ship carrying him was bombed by U.S. Navy aircraft, killing Bianchi.

His bravery was recognized posthumously, and on June 7, 1945, his mother received his Medal of Honor. General Douglas MacArthur later praised Bianchi's sacrifice, crediting soldiers like him for delaying the Japanese advance and aiding the U.S. war effort. His body was never recovered, but his name is memorialized at the National Memorial Cemetery of the Pacific in Honolulu and the Manila American Cemetery.

Bianchi's legacy endures through numerous honors, including a street named after him in New Ulm, the renaming of its American Legion post, and a memorial and scholarship at South Dakota State University. His Medal of Honor and decorations remain on display at the Brown County Historical Society Museum, preserving the memory of his extraordinary valor.

Let us remember the following Comrades who passed away since our last publication March 2025.



## A LITTLE BIT OF HISTORY

April 11 marked the 34th anniversary of the formal end to the Persian Gulf War, and the Veterans of Foreign Wars (VFW) continues to honor and pay tribute to the nearly 700,000 military men and women who served in Operations Desert Shield and Desert Storm.



On April 11, 1991, less than 90 days after the U.S.-led offensive against Iraq known as Operation Desert Storm began, the United Nations Security Council declared the conditions of Resolution 687 in effect, making the cease-fire official and formally ending the Persian Gulf War. The definitive victory elevated the United States as the preeminent global superpower and the number one partner of choice for its allies around the world.

American soldiers, sailors, airmen, Marines, and Coast Guardsmen served in the Gulf War, ensuring one of the swiftest, most decisive victories in U.S. history. However, the price paid for this victory is often overlooked. We must never forget the cost of war and the 374 dead, 467 wounded, and the two servicemen whose remains have yet to come home.

On behalf of a grateful nation, the VFW remembers this momentous event for our country and for liberty. We continue to recognize the courage of these brave men and women who fought to liberate a nation more than 7,000 miles away from American shores, and whose service left an indelible mark on history.

We honor all Gulf War veterans – men and women who dedicated themselves to accomplishing their mission and protecting freedom halfway around the world. We stay committed to the fight for their health care and benefits on Capitol Hill and say “thank you” for their service and sacrifice more than 34 years ago.



## SOME AMAZING FACTS

In September 2005, on the first day of school at Robinson High School in Little Rock, Arkansas, history teacher Martha Cothren did something that left a lasting impression.

With permission from the school superintendent, principal, and building staff, she had every desk removed from her classroom before students arrived. So when her first-period students walked in, they were met with a completely empty room.

Confused, one of them asked, “Ms. Cothren, where are our desks?”

She answered, “You won’t have a desk until you tell me how you’ve earned the right to sit at one.”

They guessed — maybe it was good grades? Good behavior? Each time, she simply said, “No.”

As the day went on, each class came in, puzzled, and left without answers. Word spread quickly. Parents started calling the school. Local news crews even showed up, curious about the teacher who had taken all the desks away.

Finally, during the last period of the day, the mystery was solved.

Ms. Cothren stood at the front of the class and said, “Throughout the entire day, not one of you has been able to tell me what you did to earn the right to sit at these desks. Now I’m going to show you.”

She walked to the classroom door and opened it.

Twenty-seven U.S. military veterans, all in uniform, entered the room — each one carrying a student desk. In silence, they placed the desks in neat rows and then stood along the walls.

As the students watched, realization began to set in.


“These men and women,” Ms. Cothren said, “earned your right to sit at these desks. They gave up their own education, put their lives on hold, and traveled around the world — many into combat — so that you could have the freedom to learn in a safe place.”

She paused, letting it sink in.

“It’s your responsibility now — to be good students, to be responsible citizens. Never forget that your freedoms were paid for by others. Always remember who earned them for you.”

This powerful moment was very real. Martha Cothren, the daughter of a WWII prisoner of war, was later honored as Veterans of Foreign Wars Teacher of the Year for Arkansas in 2006.

Freedom isn’t free, it’s worth remembering the people who sacrificed so we can enjoy it.



# POW/MIA CHAIRMAN

In 2024 and 2025, numerous events commemorating the 80th anniversary of the end of World War II in the Pacific Theater were held. Many of these events focused on the treatment of prisoners of war (POWs) and the issue of missing in action (MIA) personnel. Members of the Veterans of Foreign Wars (VFW) throughout the Department of Pacific Areas (DPA) actively participated in these observances, showcasing their commitment to the motto, "No One Does More for Veterans".

As my term as the DPA POW/MIA Chairman comes to an end, I would like to offer an overview of the United States personnel missing in Action (MIA) in the Pacific Theater during World War II, the Korean War, and the Cold War.

## American Missing in Action

At the end of World War II, 78,750 Americans were classified as MIA, with half lost in the Indo-Pacific. The Korean War added over 8,000 MIAs. The U.S. honors fallen service members through Memorial Day (last Monday in May) and National POW/MIA Recognition Day (third Friday in September), the latter established by President Carter. The 2019 National POW/MIA Flag Act mandates displaying the POW/MIA flag at federal sites like the Capitol and White House.

Post-war recovery transitioned to the American Graves Registration Service (AGRS), now managed by the Defense POW/MIA Accounting Agency (DPAA). Ongoing efforts have reduced MIA numbers through remains identification and site investigations.


## Current MIA Statistics (2025):

World War II: 71,986 unaccounted (~65% in Indo-Pacific)  
Korean War: 7,446  
Vietnam War: 1,544  
Cold War: 126 (108 in Asia, 8 in Europe)  
Gulf Wars/Other: 6

Approximately 75% of unresolved cases are concentrated in the Indo-Pacific, with over 41,000 presumed lost at sea. The DPAA reports 81,137 total unaccounted personnel across all conflicts, while the American Battle Monuments Commission cites 84,768 MIAs (including 4,423 from WWI). These figures reflect the enduring legacy of U.S. military sacrifices and the persistent mission to achieve full accountability.

## A LITTLE BIT OF HISTORY

Johnny Cash Once Demanded that Kris Kristofferson, who was a janitor at the time for Columbia Records, Be allowed to sit in on one of his recording sessions. And it all started with Kristofferson being banned from Johnny's recording sessions...Kris in his own words.

Kristofferson: "I almost got fired one time because a couple of songwriters crashed the session, and they were trying to pitch him a gospel album. And for some reason the woman who was the secretary to the producer blamed me for letting them in there and tried to get me fired.

And so the next night my boss came down and said "I don't think you should go to John's session tonight," which was heartbreaking for me because I lived for those recording sessions....But I understood it."

Johnny was not happy to hear that Kris wouldn't be sitting in on the recording session.

Kristofferson: "I hid down in the vault of the recording studio and was erasing tapes down there or doing some kind of busy work, and John appeared down there in the basement.

He said "I understand you're not coming to the session."

I said "No, I've got a lot of work to do down here, I can't.


He said "Well I just wanted to tell you I'm not gonna record until you come up there.

So I had to go up there and sit on the floor.

Kristofferson: "And here I was, the janitor, and I'm sitting on the floor and this woman who tried to get me fired was watching me and the whole session. It was the most uncomfortable I've ever been in my life.

But I thought it was the measure of the man. He always stood up for the underdog....And that's something I've tried to live up to. He's been a good example."

Kristofferson said this whole experience was an example of who Johnny Cash really was.



# LEGISLATIVE CHAIRMAN

Comrades, with the March 2025 Washington Conference now in the books, it was a pleasure taking DPA CDR Lutman, National Council member Stine and the Early Bird winner around the halls of congress. This year we had schedules to meet with the Legislative Assistant from the Office of Congresswoman King-Hinds, Ms. Ewing and Legislative Assistant from the office of Congressman Moylan, Mr. Lukas and Ms. Braiotta. We pitched the VFW March PRIORITIES which consist of the following issues:

- Unaddressed Toxic Exposures: this is an extension to the PACT Act bill to have the VA report on all newly found toxic exposures to be added.
- Transition from Service: (TAP Promotion Act) to codify VA's practice of including accredited claims representatives from national, state, and local organizations in joining TAP classes.
- **UPDATE:** Congress re-introduced on 03/05/2025, bill H.R. 1845 TAP Promotion Act.
- Exploring Alternative PTSD Treatments: Direct the Department of Defense and VA to implement innovative PTSD treatments currently used in the private sector. Direct VA to review its current mental health treatments and prescribing practices to address the possible over-reliance on pharmaceutical interventions.
- Cracking Down on Predatory Claims Companies: The VFW is concerned that bad actors are preying on veterans by skimming their earned Department of Veterans Affairs (VA) benefits. Pass legislation that would prohibit the exploitation of veterans and survivors by unscrupulous Claim Sharks and strengthen the accreditation system.
- **UPDATE:** Under the 119th Congress (2025-2026) re-introduced as, H.R.1732 - GUARD VA Benefits Act.
- Guard and Reserve GI Bill Parity Act of 2025: To allow any day in uniform for which military pay is received to count toward Post-9/11 GI Bill eligibility, creating equity for National Guard and Reserve members
- Retirement and Military Personnel: For more than two decades, Congress has failed to address the long-standing injustice of withholding military retirement pay from disabled veterans. Department of Defense (DOD) military retirement pay and Department of Veterans Affairs (VA) disability compensation are separate, distinct benefits earned for different reasons, yet
- Congress continues to wrongly treat their concurrent receipt as "double-dipping." The VFW believes this policy
- is fundamentally unfair,
- **UPDATE:** Congress re-introduced, bill H.R. 2102 Major Richard Star Act

**Independence Day the Fourth of July or July 4\*** is a federal holiday in the United States commemorating the Declaration of Independence of the United States, on July 4, 1776. The Continental Congress declared that the thirteen American colonies were no longer subject (and subordinate) to the monarch of Britain, King George III, and were now united, free, and independent states. The Congress had voted to declare independence two days earlier, on July 2, but it was not declared until July 4.



**The Korean Armistice signed on 27 July 1953\*** After three years of a bloody and frustrating war, the United States, the People's Republic of China, North Korea, and South Korea agree to an armistice, bringing the fighting of the Korean War to an end. The armistice ended America's first experiment with the Cold War concept of "limited war."



**4 August 1790** - The United States Coast Guard, one of the country's six armed services, is a unique agency of the federal government. We trace our history to 4 August 1790, when the first Congress authorized the construction of ten vessels to enforce tariff and trade laws and to prevent smuggling. Known variously through the nineteenth and early twentieth centuries as the Revenue Marine and the Revenue Cutter Service, we expanded in size and responsibilities as the nation grew.
